WAIVER, RELEASE OF LIABILITY, INDEMNITY, ASSUMPTION OF RISK AGREEMENT, AND PARTICIPATION AGREEMENT

- Agree to indemnify and hold harmless the Releasee from any claims, loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activities, whether caused by negligence of Releasee or otherwise.
- Acknowledge and understand that I will be voluntarily engaging in activities (including physical activities that involve falling and contact) that have inherent risks and dangers, and might result in serious injury or illness, including permanent disability or death, and severe social or economic losses due to actions, inactions or negligence of my own or of others, or conditions of the premises or of any equipment used; and further, acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
- Assume all of the foregoing risks and accept personal responsibility for the damages following such injury, illness, permanent disability, or death.
- Understand and agree that prior to participating, I have the right and duty to inspect any mats or equipment and the facilities to be used, and if I believe that anything is unsafe or beyond my ability I will immediately advise the instructor or supervisor of such condition(s) and refuse to participate.

- Represent that I am an adult of at least eighteen (18) years of age, and to the

- Agree that the foregoing waiver, release of liability, and assumption of risk agreement shall be construed in accordance with the laws of the State of New York, and is intended to be as broad and inclusive as is permitted by the law of the State of New York, and that if any portion thereof is held invalid, illegal or unenforceable, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect to the fullest extent permitted by law.

I HAVE CAREFULLY READ THE ABOVE WAIVER, RELEASE OF LIABILITY, INDEMNITY, ASSUMPTION OF RISK AGREEMENT, AND PARTICIPATION AGREEMENT. I UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT AND KNOWING THIS, I SIGN IT VOLUNTARILY.
